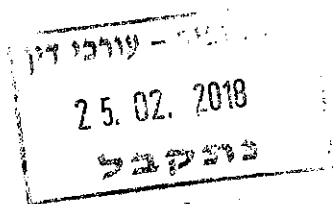

Re: **Mr. Benzi Gopstein**

1. We act for Facebook Ireland Limited ("Facebook Ireland"), and write in response to your email dated January 23, 2018, sent on behalf of your client, Mr. Benzi Gopstein. Due to the scant factual allegations in your email, Facebook Ireland is unable to respond substantively regarding your client's complaints.
2. We understand that your client has publicly espoused and promoted hate speech. Hate speech has no place on our client's service and is against its terms and policies. Our client's terms and policies are politically neutral and allow a wide range of political opinions, including those that may be considered offensive by some. However, they prohibit hate speech and content that directly attacks people based on their race, ethnicity, nationality, religious affiliation, sexual orientation, sex, gender or gender identity, or serious disability or diseases. Organizations or people dedicated to promoting hatred against these groups are not allowed a presence on Facebook. Our client treats seriously each and every violation of its

terms and policies, which is why it may delete content, profiles and sites that are reported to it as violating these rules.

3.
